- a) external member representing donors; and. (One Member)
- b) two additional persons with financial, ICT, Artisan and Engineering.

1. Applicants:

Citizens who wish to contribute towards social economic development through uMfolozi TVET College who have the minimum relevant academic qualification, i.e.

- a) **Information, Communication and Technology field:** Comprehensive content knowledge; an ICT qualification (a degree in Human Resource will be an added advantage).
- b) **Engineering/Artisan field:** Comprehensive sector knowledge; an equivalent artisan related qualification any post Artisan qualification will be an advantage
- c) **Donor:** Comprehensive TVET Sector knowledge; a bachelor's degree; part of organised business.
- d) **Applicants must** at least have 5 years' experience in a senior position in the relevant field, and the required competencies as listed below, are invited to apply.

2. Expertise and methodological competencies:

- a) Expert knowledge of Technical Vocational Education and Training (TVET) and the role Colleges play in the overall post schooling sector in South Africa,
- b) Experience in strategic planning and decision making,
- c) Understanding of the linkages between the 'world-of-work' and the post schooling sector to give relevant strategic advice and/or is able to synthesise relevant strategic issues,
- d) Understands the importance of the Programme Qualification Mix (PQM) and how the right PQM can support employability of students (ability to assess and translate client needs),
- e) Experience in governance structures of public institutions and/or private enterprises,
